## LGPC bulletin 246

The LGPC have published <u>Bulletin 246</u> (January 2024) on the bulletins page of <u>www.lgpsregs.org</u>.

  Please ensure that your payroll applies the new bandings from 1 April 2024
- Confirmation of annual revaluation, earnings and pensions increase
- Interim chair of the Pensions Ombudsman (TPO) appointed

# 2024/25 employee contribution bands

Table 1 sets out the employee contribution bands effective from 1 April 2024. These are calculated by increasing the 2023/24 employee contribution bands by the September 2023 C P I figure of 6.7 percent and then rounding down the result to the nearest £100.

Please ensure this information is received by your payroll and actioned from 1 April 2024.

5	£56,801 to £79,700	8.50%	4.25%
6	£79,701 to £112,900	9.90%	4.95%
7	£112,901 to £133,100	10.50%	5.25%
8	£133,101 to £199,700	11.40%	5.70%
9	£199,701 or more	12.50%	6.25%
